A motion was made by Director Soderline and seconded by Director Cavey to ratify invoices presented. Motion carried unanimously.

# D. BOARD ELECTION OF 2023 CHAIR AND VICE-CHAIR (LORA THOMAS)

Traditionally the Chair and Vice-chair positions have rotated with the Chair not making a motion.

Director Dahlkemper motioned to approve Director Cavey rotate to the Chair position and was seconded by Director Soderlein. Motion carried unanimously.

Director Cavey made a motion for Director Dahlkemper to rotate to the Vice-chair position and was seconded by Director Martin. Motion carried unanimously.

Director Thomas will serve as Chair through the end of this board meeting at which time Director Cavey will begin as Chair.

# E. APPROVE DESIGNATION OF CHATFIELD WATERSHED AUTHORITY AS PUBLIC NOTICE LOCATION (DIANE KIELTY)

Director Cavey made a motion that the CWA Board designate its website at "chatfieldwatershedauthority.org" as its location for public notice. Director Dalkemper seconded the motion. Motion carried unanimously.

# F. VOTE ON BYLAW AMENDMENT FOR SOLE SOURCE CONTRACTS (MICHAEL DAUGHERTY)

A recommendation on a bylaw amendment to allow CWA sole source contracting was provided in the meeting packet and was discussed. This recommendation was suggested to make CWA more efficient. A recommendation was made by Director Cavey to add language to require a unanimous vote by the Board to approve a sole source contract.

A motion was made by Director Cavey to accept the bylaw amendment as written in the recommendation memo with the additions that a unanimous board vote is required for sole source contract approval and to require such contracts be less than one year and under \$60k. The motion was seconded by Director Soderlein. Motion carried unanimously.



# DISCUSSION ITEMS (4:15 P.M. - 4:45 P.M.)

# A. CWA HISTORICAL NUTRIENT TRENDS (ALAN LEAK)

CWA will be in compliance for total phosphorus and chlorophyl a in 2022.

# B. PROJECT FUNDING UPDATE (ALAN LEAK)

The projects discussed in the CWA Priority List of Activities and Projects are a projection over the next 5 years to maintain and improve water quality. CWA Lobbyists met with DNR and presented the list. DNR suggested that whatever funding CWA can get, DNR would support it. They also met with CDPHE regarding the recommended projects. CDPHE said that some of the projects would require significant match. CDPHE was referring to 319 funds that would require 25% match. This will be researched.

The Lobbyist are looking at finding funding for the Authority through legislation. This effort is proposing 2024 to run a bill. Funding partners are being considered to improve the scale of projects through inkind and money match. Chatfield Reservoir has had more visitors over the year surpassing Cherry Creek, but CWA's budget is considerably smaller.

Requesting a meeting with the CDPHE staff on the Supplemental Environmental Program to get some traction with this group is a desired next action.

# UPDATES (4:45 P.M. – 5:55 P.M.)

# A. TECHNICAL (ALAN LEAK)

- 1. Response actions to Sun Jelly WWTD wasteload allocation violations RESPEC has not heard back from Sun Jelly on this violation. Alan Leak will follow-up with CDPHE. If a fine is the result, RESPEC plans to have a project ready in the queue to submit.
- Pine Canyon Response Letter CDPHE responded with an approval on the site application for this facility. RESPEC was directed to write a response letter to the Division with recommended items to be associated with a permit approval should this be the outcome. The CWA response letter was provided in the meeting packet.
- 3. Perry Park Waucondah Site Application Amendment This was an amendment process. Perry Park is a CWA member; being an upgrade, the process is quicker. CWA TAC approved and the approval was submitted.
- 4. Sellars Gulch Coliform Speciation Analysis update There have been several discussions on this issue and the determined desire was to identify the source of the issue. A quote from GEI was provided on coliform testing. Colorado School of Mines does not have the equipment for this type of study. Recommend this be performed at the same time of year as CSM samples have been taken. It would fall within \$5,000 for the project. There was



discussion on who would be best to conduct this sampling given it is in Castle Rock. Castle Rock is checking for a leaking sewar line. If this does not reveal the source, Castle Rock will move on to a coliform analysis. The suspicion now is animal waste as the cause. CWA will defer to the Town of Castle Rock to pursue this effort. Castle Rock has tested along the reach and coliform is showing up throughout which is an indicator that it may be animal. The Authority has done speciation studies in the past.

Action: Manager will check the archives for speciation studies.

- 5. Lynker Modeling update The study is complete, and the TAC received a draft report in November. The consultants have been working on the final analysis to move forward on the TMAL. This model will help with the TMAL revisions. A final report will be made available for review at the March TAC meeting.
- 6. Annual Report request for input RESPEC is working on the Annual report for 2022 which is due on May 15, 2023. RESPEC will be reaching out to the members for information.

# B. LEGISLATIVE (STEVE BALCEROVICH & AMY ATTWOOD)

Steve Balcerovich presented an overview of the political landscape. To secure Chatfield funding, late bill request paperwork has been submitted. Initial signs are encouraging. Potential bill sponsors, Senator Cutter and Van Winkle, were discussed. Lobbyists have met with DNR and CDPHE. They were supportive of CWA needs. Chatfield is the second most visited park in the State. Most funding requires significant matching funds. Cherry Creek is still a model to be considered. The path leading toward is a user fee with a 5-year sunset. The fee would be a passthrough, so it doesn't affect TABOR. The list of projects has been provided to bill sponsors and staff. Colorado Counties Inc. is lobbying for Keep Colorado Wild Pass money. A link to the bill list was provided. There was a discussion on the sunset timeline. A sunset approach makes it easier to move a bill through. The 5-year sunset was selected to align with the projects list. Once the late bill is initiated and a draft bill is signed, CWA members can start reaching out to potential supporters to broaden the coalition.

# C. LEGAL (MICHAEL DAUGHERTY)

 Lakes Nutrients Criteria Rulemaking Update (links provided)
 A legal report was provided in the packet. EPA has requested that CDPHE reevaluate Chatfield's standard to be site specific. Plum Creek also supported a site specific standard. February 15<sup>th</sup> is the deadline to file rebuttal statements.

The 2023 budget will be monitored closely, and TAC will be made aware to allow CWA to participate in this rulemaking to the level desired.
